**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
MAINSTREAM ENVIRONMENTAL, INC.**

Pursuant to the provisions of Sections 607.1002 and 607.1006 of the Florida Statutes, MAINSTREAM ENVIRONMENTAL, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is MAINSTREAM ENVIRONMENTAL, INC.
2. The original Articles of Incorporation for the Corporation were filed on November 1, 1999, and assigned Charter No. P99000095845.
3. In a Written Consent to Action of the Sole Director executed on November 16, 1999, the sole Director has approved, authorized and directed that the Articles of Incorporation be amended to change the name of the Corporation to "CENTRAL FLORIDA REFUSE, INC.".
4. The Corporation has not issued shares of common stock of the Corporation and shareholder approval of these Articles of Amendment will not be required.
5. Article I of the Articles of Incorporation is hereby amended to read as follows:

**ARTICLE I - NAME**
