**ARTICLES OF INCORPORATION**

The undersigned, licensed or otherwise legally authorized to practice as a certified public accountant in the State of Florida, hereby acting as incorporators for the purpose of forming a professional service corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, do hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of this corporation is:

Florida CPA Services, P.A.

**ARTICLE II: PURPOSE**

The purpose for which this Corporation is organized is to engage in the practice of certified public accounting, and to take all actions therein necessary and proper in that respect.

**ARTICLE III: CAPITAL STOCK**

The Corporation shall have the authority to issue one thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00) per share. There shall be only one class of shares.

**ARTICLE IV: INITIAL REGISTERED OFFICE AND AGENT**

The initial street address of the registered office of the Corporation in the State of Florida shall be 1001 3<sup>rd</sup> Ave. W., Suite 350, Bradenton, Florida 34205, and the initial registered agent at such address shall be KEVIN W. GEISLER.

## **ARTICLE V: PROFESSIONAL SERVICES**

The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice certified public accounting within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by this Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of Certified Public Accounting.

## **ARTICLE VI: INITIAL PRINCIPAL PLACE OF BUSINESS**

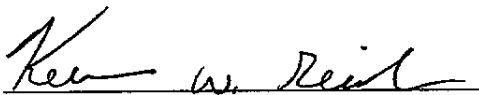
## **ARTICLE IX: AMENDMENTS**

## ARTICLE X: BYLAWS

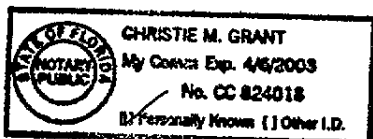

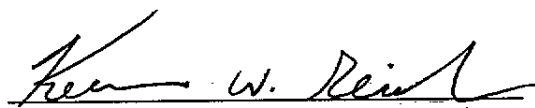
