<u> ARTICLE I - NAME</u>

NOVA 2000, INC.

The name of this corporation is _____located at 2955 Pineda Causeway, Suite 119, Melbourne, Florida 32940.

ARTICLE II - DURATION

ARTICLE XIII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XIV - I.R.C. SECTION 1244 STOCK
