ARTICLES OF INCORPORATION

of

ILONA DALE REUTER, ARNP, P.A.

The undersigned incorporator and subscriber to these Articles of Incorporation, being duly licensed to engage in the profession of Nurse Practitioner under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is
ILONA DALE REUTER, ARNP, P.A.

ARTICLE II - PURPOSE

The professional service corporation is formed to engage in every phase of the profession of Nurse Practitioner.

ARTICLE III - TERM OF EXISTENCE

The professional service corporation shall have perpetual existence commencing on the date these Articles of Incorporation are filed with the Department of State of the State of Florida.

ARTICLE IV - CAPITAL STOCK

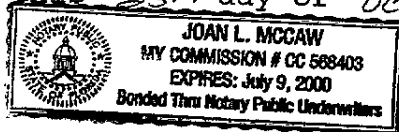
