**ARTICLE IV. ADDRESS**

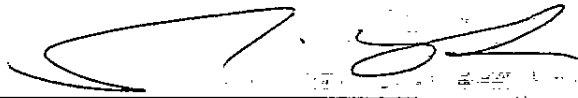

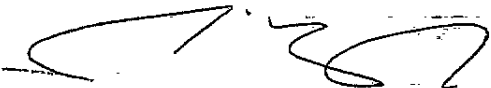
