ARTICLE VIII - AMENDMENT

This certificate of incorporation may be amended in any manner with the laws of the State of Florida.

ARTICLE IX - OFFICERS

The officers of the corporation until the first meeting of the corporation Board of Directors, or until successors are elected, shall be:

John Clastkewicz- President, Secretary, Treasurer

#### ARTICLE X

This corporation shall be initially geverned by the stockholders. notwithstanding other provisions ο£ these Incorporation.
