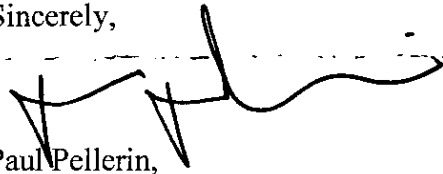
Dear Reader:
