# ARTICLES OF INCORPORATION OF

The undersigned, Heinfred Vagts, files in the Office of the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit, in accordance with the laws of the State of Florida, these Articles of Incorporation, as by law provided.

#### I. NAME:
