ARTICLE VI - BOARD OF DIRECTORS





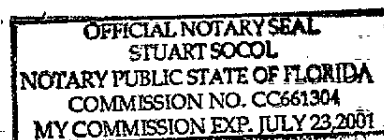
