ARTICLES OF INCORPORATION OF

THE ST. ARMANDS LAW GROUP OF SARASOTA,

The undersigned incorporators, being competent to contract, subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be ST. ARMANDS LAW GROUP OF SARASOTA, P.A. The principal address of this corporation is 400 Madison Drive, Suite 250, Sarasota, FL 34236.

ARTICLE II - BUSINESS AND ACTIVITIES

This corporation may, and is authorized to, engage in the providing of legal services as permitted under the laws of the United States of America and the State of Florida.

ARTICLE III - CAPITAL STOCK

The authorized capital stock of this corporation and the maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock having a par value of NONE per share.
