# ARTICLES OF INCORPORATION SECRETARY PARTIES OF STATES

## VENTURENET FUNDING GROUP, INC.

## ARTICLE I

I, TIM CRAWFORD, whose post office address is 8917 North Davis Highway, #121, Pensacola, Florida 32514, being at least eighteen years of age, hereby form a corporation under and by virtue of the General Laws of the State of Florida.

### ARTICLE II

of the Corporation (hereinafter called the The name "Corporation") is: VENTURENET FUNDING GROUP, INC.

# ARTICLE III

The purposes for which the Corporation is formed are:

(1)To engage in any business or activity not prohibited by law.

### ARTICLE IV...

The post office address of the principal office of this Corporation is this state is 8917 North Davis Highway, #121, Pensacola, Florida 32514. The name and post office address of the Resident Agent in this state are Tim Crawford, 8917 North Davis Highway, #121, Pensacola, Florida 32514.

### ARTICLE V

The total number of shares of capital stock which the Corporation has authority to issue is One Thousand (1000) shares of common stock without par value. The holders of common stock shall be entitled to one (1) vote per share in all proceedings in which actions shall be taken by the stockholders of the Corporation.

### ARTICLE VI\_\_\_

The number of directors of the Corporation shall be three, which number may be increased or decreased pursuant to the By-Laws of the Corporation, provided that the number of directors shall never be less than the minimum permitted by Florida Statute 607.0803, as amended. The names of directors who shall act until the first annual meeting and until their successors are duly chosen and qualified are:

### ARTICLE VII

The following provisions are hereby adopted for the purpose of defining, limiting and regulating the powers of the Corporation and of the Directors and stockholders:

- (1) The Board of Directors of the Corporation is hereby empowered to authorize the issuance from time to time of shares of its stock of any class, whether now or hereafter authorized, or securities convertible into shares of its stock of any class or classes, whether now or hereafter authorized.
- (2) The Board of Directors of the Corporation may classify or reclassify any unissued shares by fixing or altering in any one or more respects, from time to time before issuance of such shares, the preferences, rights, voting powers, restrictions and qualifications of, the dividends on, the times and prices of redemption of, and the conversion rights of, such shares.

The enumeration and definition of a particular power of the Board of Directors included in the foregoing shall in no way be limited or restricted by reference to or inference from the terms of any other clause of this or any other article of the Charter of the Corporation, or construed as or deemed by inference or otherwise in any manner to exclude or limit any powers conferred upon the Board of Directors under the General Laws of the State of Florida now or hereafter in force.

## ARTICLE VIII

- (1) Directors and officers of the Corporation shall not be liable to the Corporation or its stockholders for money damages. The purpose of this limitation of liability is to limit liability to the maximum extent that the liability of directors and officers of Florida corporations is permitted by Florida law. This limitation on liability shall apply to events occurring at the time a person serves as a director or officer of the Corporation whether or not such person is a director or officer at the time of any proceeding in which liability is asserted.
- (2) To the maximum extent permitted by Florida law, the Corporation shall indemnify its currently acting and its former directors against any and all liabilities and expenses incurred in connection with their services in such capacities, and shall indemnify its currently acting and its former officers to the full extent that indemnification shall be provided to directors, and shall indemnify, to the same extent, persons who serve and have served, at its request as a director, officer, partner, trustee, employee or agent of another corporation, partnership, joint venture or other enterprise. The Corporation shall advance expenses to its directors and officers and the other persons referred to above to the extent permitted by Florida law. This includes the indemnification of directors and officers who are also employees, in their capacity as employees. The Board of Directors

may by By-Law, resolution or agreement make further provision for indemnification of employees and agents to the extent permitted by Florida law.
