#### **ARTICLES OF AMENDMENT**

TO

## ARTICLES OF INCORPORATION OF OMNI DRYWALL, INC.

Pursuant to the provisions of § 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

These Articles of Amendment modify provisions of **Omni Drywall, Inc.,** [referred to herein as the "Corporation"] a Florida corporation, doing business in Okaloosa County, Florida. For the purpose of this Amendment, and at the time of the authorization of this Amendment, the Corporation presently has an owner/sole shareholder; Dennis Paul Bellnier. The Owner/Sole Shareholder has determined that it is in the Corporation's best interests to change certain aspects of its corporate charter. That corporate charter as originally filed on November 1, 1999, and assigned Document No.: P99000096401, is therefore amended as follows:

## AMENDMENT ONE - ARTICLE VIII - Board of Directors

Article VIII is hereby amended by deleting the existing language and inserting in its place the following:

"The business of the corporation shall be managed by the shareholders. There shall be no Board of Directors."
