
RE: Annual Filing for LW Exotic Art, Inc. P99000096620

Gentlemen:

I am making a last request to your office to please waive the penalty on my annual filing for my corporation. As I stated in a letter with my previous filing, I did not receive the first notice and I was not aware that I needed to file the report by May 1. If I had known, I would have filed within the proper time period. Once I did find out that I needed to file, I did file, which happened to be in June. The filing was returned, insisting that I must pay an additional \$400 fine for late filing. I am just a small business and I cannot afford to pay this fine. I do not feel that I should be penalized for something that I did not receive and was not aware that I needed to do. If the penalty cannot be waived, then I will have no choice but to dissolve my corporation and terminate my business. If this is the way the State of Florida wants to treat small businesses, then I no longer wish to conduct business as a Florida corporation.

I am enclosing another filing hoping that you will give due consideration to my request. If not, then I will need the appropriate forms or information required to dissolve my corporation in the State of Florida.
