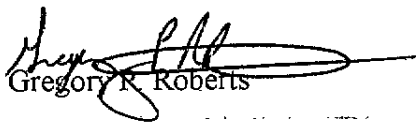

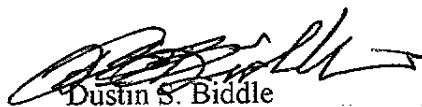

**Articles of Incorporation
of
Primal Studio Productions, Inc.**

**I.
Name**

The name of the Corporation is Primal Studio Productions, Inc., hereinafter referred to as the "Corporation."

**II.
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

**III.
Principal Office and Registered Agent**

The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. Duration**

The duration of the Corporation shall be perpetual.

**V.
Initial Business**

The initial business of the Corporation shall be retail sales, wholesale sales, services, and software productions.

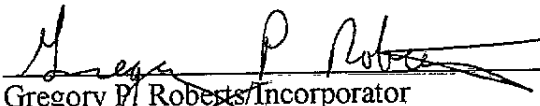

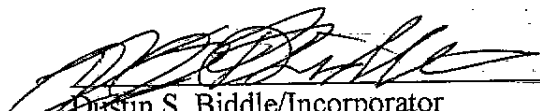

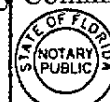
