#### ARTICLES OF INCORPORATION

OF CARIM LAUNDRY EQUIPMENT CO., INC.

The undersigned Incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

Article 1. Name

The name of the corporation is Carim Laundry Equipment Co., Inc.


