NAME

The name of this corporation is MASTER CHASE, INC.

DURATION

This corporation shall have perpetual existence.

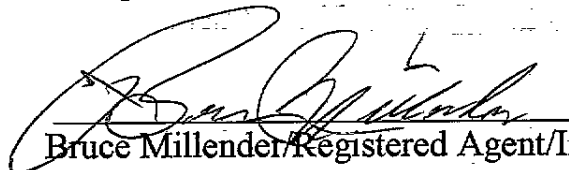
