The name of this corporation shall be: OCCASIONALLY YOURS SILKS,

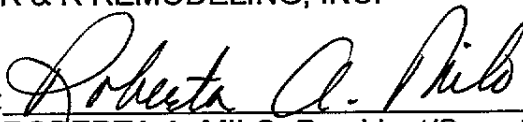
