**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, being a natural person, competent to contract, hereby associates herself to form a corporation under the law of the State of Florida. This Corporation shall have perpetual existence.

ARTICLE I - NAME

ARTICLE II - PURPOSE

ARTICLE V - ADDRESS OF PRINCIPAL OFFICE



ARTICLE XI -


MANAGEMENT OF CORPORATION BY DIRECTORS AND OFFICERS


