**ARTICLE I. CORPORATION NAME**

ARTICLE IX. AMENDMENT

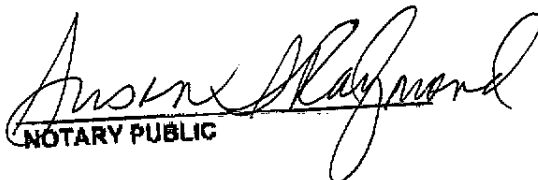
