ARTICLES OF INCORPORATION OF ____ FLORIDA RUST, INC.

THE UNDERSIGNED INCORPORATOR to these Articles of STATE Incorporation is a natural person competent to contract and form a corporation under the laws of the State of Florida, and does certify that he has become a corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is FLORIDA RUST, INC.

The principal place of business of this corporation shall be 1117

Egret Lane Way, Melbourne, Florida 32940.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1 par value per share.

ARTICLE IV. ADDRESS
