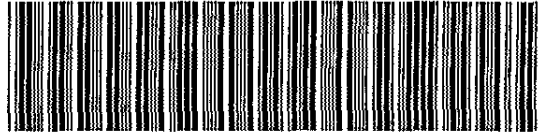

WHEREAS, the Directors and owners of all the common stock of JONATHAN M. GREER, M.D., P.A., a Florida corporation, did unanimously approve at a meeting of the shareholders and directors held October 3, 2003, subject only to the approval thereof by the Secretary of State, State of Florida, amending Articles I and III of its Articles of Incorporation for the purpose of changing the name of the corporation and amending the provision relating to the purpose of the corporation.

1620 South Congress Avenue, Palm Springs, Florida 33461."

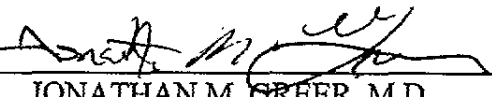
"ARTICLE III - PURPOSE
