ARTICLE I • NAME

The name of this Corporation is Tinnitus Retraining Therapy Centers of South Florida, Inc. principal office and mailing address is 9910 Sandalfoot Blvd. Suite 7, Boca Raton, FL. 33428.

This Corporation shall exist perpetually commencing on the date these Articles are filed.

The power to adopt, amend, alter, rescind or repeal the By-laws shall be vested in the Board of Directors and the shareholders.


ARTICLE X • POWERS



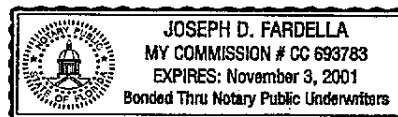


