**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
MARTIN & ROOT, P.A.**

Pursuant to the provisions of FS § 607.1001 and FS § 607.1002, the undersigned corporation submits the following articles of amendment:

1. The name of the corporation is Martin & Root, P.A.
2. The following amendments to the articles of incorporation were adopted by the Board of Directors on November 20, 2000.

Article I. Name and Purpose

The Name of the corporation shall be Douglas Root Architects, Inc.
