ARTICLES OF INCORPORATION  
OF  
AL & IRIS ANNAS, INC.

ARTICLE I. NAME

The name of this corporation is AL & IRIS ANNAS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

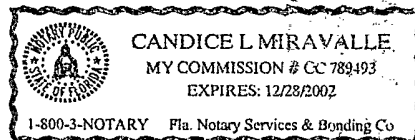


