ARTICLES OF INCORPORATION OF RIVER OAKS HOUSING ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

<u>Article i</u>
