The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is JOHN L. WOODARD, III, P.A. and the principal address for the corporation is 320 N. Magnolia Avenue, Suite A-6, Orlando, Florida 32801.

ARTICLE II. DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE III. PURPOSE

The corporation is organized for the purposes of the practice of law and any and all lawful business for which such corporations may be incorporated in the State of Florida.

ARTICLE IV. CAPITAL STOCK


