**ARTICLE I**

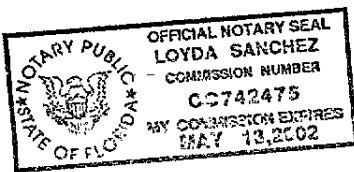
