These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in chapter 607 of the Florida Statutes.

#### ARTICLE I. NAME

The name of this corporation shall be DM TRASCRIPTION SERCICES, INC.

#### ARTICLE II. DURATION

The corporation shall commence upon the filing of these Articles of Incorporation, and shall have perpetual existence thereafter.

## ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to provide business and professional support services to health, medical, legal and related organizations.

## ARTICLE IV. CAPITAL STRUCTURE
