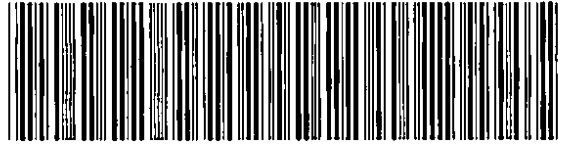

SECOND: The document number of the Corporation is P99000097235.


