**ARTICLE I

APPROVAL OF DISSOLUTION**

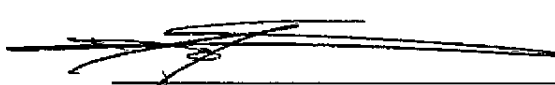
The dissolution was approved by all of the shareholders of the Corporation by written consent dated December 31, 2001, pursuant to Section 607.0704 of the Florida Statutes.
