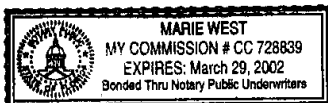
1. Valerie Cairney is the President of SCOTTISH BANNER, INC., a Florida corporation, (hereinafter "Corporation").
