ARTICLE XI - Amendment

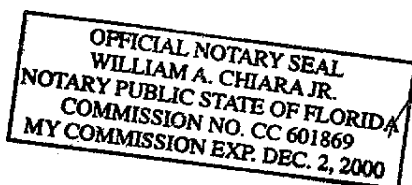
