NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

PURPOSE

This corporation, through its officers and employees,

through its officers and employees; and to invest and reinvest
its funds in real estate, mortgages, stocks, bonds and any other
type of investments within the meaning of F.S. §621.08 of the
Professional Service Corporation Act; and to purchase and own

Shareholders may amend, repeal, or alter the By-Laws in whole or in part at any shareholders' meeting, regular or special, by the majority vote of the shareholders present, if the proposed amendment or change be included in the notice to shareholders or waivers of notice be obtained.
