I the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby associated to form a Corporation under the Laws of the State of Florida.

ARTICLE I  
NAME OF CORPORATION

The name of the Corporation shall be BEST QUALITY SERVICE, INC.

ARTICLE II  
NATURE OF BUSINESS

The general nature of business to be transacted by this Corporation shall be maintenance and services, and any other activities of business permitted under the Laws of the United States of the State of Florida. To manufacture, purchase, or otherwise acquire, and to own, mortgage pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, dealing, and with goods, wares, merchandise, real and personal property, and services of every kind, class and description, except that is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad, cancel, telegraph, cooperative association, fraternal benefit society, state fair or exposition.

To conduct business in, have one or more offices in, and buy, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchise, patents, copyrights, trade-marks, licenses, in State of Florida and in all other States and Countries.  
To contract debts, and borrow money, issue and sell or pledge bonds, debentures, noted and other evidence of indebtedness as required.

To purchase corporate assets of any other corporation and engage in the same or other character or business. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock of any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner such stock, o exercise all rights, powers and privileges of ownership, including the right to vote such stock.

ARTICLE III  
CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock at \$1.00 par value per share.


