**ARTICLES OF INCORPORATION
OF
BRUCE CUNNINGHAM'S LAWN SERVICE, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME

The name of the corporation shall be: Bruce Cunningham's Lawn Service, Inc.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in the maintenance and landscaping of lawns and property to include the mowing, trimming, fertilizing, weed control and modifying the existing land by clearing, grading and/or decorative planting.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having \$1.00 par value per share.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V. DIRECTORS

The business and affairs of this corporation shall be managed and shall be under the direction of the officers and directors of this corporation. The officers and directors may take action by written consent without a meeting as provided by law and may participate in meetings by means of conference as provided by law. ARTICLE IX. AMENDMENT

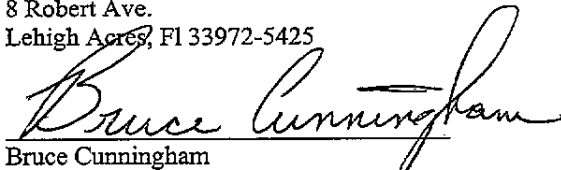
