- ARTICLE I.** The name of the corporation is The Connection Real Estate Investments, Inc. at 11530 S.W. 14th Avenue, Miami, Florida 33186.
- ARTICLE II.** This corporation shall have perpetual existence, unless sooner dissolved according to law.
- ARTICLE III.** This corporation is organized for the following purpose:
To engage in the transaction of any and all lawful business whatsoever.
