ARTICLES OF INCORPORATION OF SMART TRAFFIC TECHNOLOGY, INC.

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is SMART TRAFFIC TECHNOLOGY, INC. and the principal address for the corporation is 708 Grandview Avenue, Altamonte Springs, Florida 32701.

ARTICLE II. DURATION

The corporation shall have perpetual existence unless sooner dissolved according to law.
