Because of these changes I didn't receive this form until 7/6/01 (As you can see on the yellow "Change of Address Label" from the Post Office.


Could you please see that my new and latest address of 330 Hayes Street, Apt 4, Hollywood, Fl 33019 is in your system.

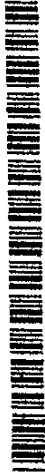
