OF

ARTICLE 1. - NAME

The name of the corporation is TRIUMPH, INC.

ARTICLE 2. - PRINCIPAL OFFICE

ARTICLE 4. - PURPOSE

against them or incurred by them in their capacity as officers and directors or arising out of their status as such.

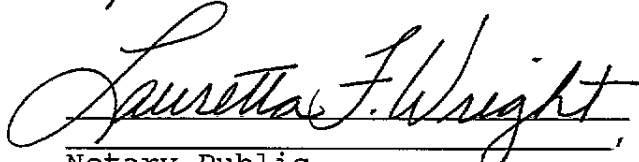
