

I would like to request a waiver of the \$400 late fee which I have just been made aware of and which I feel has been applied inappropriately. New Homes of America was incorporated in November of 1999 and the only notice of the required UBR that was received was the Second Notice which was received subsequent to the May 1 filing deadline. I'm not aware of why we never received the first notice unless it was the timing of incorporation, but I hope that a waiver is possible in this case. Being a new corporation (i.e. still in the red) the \$400 late fee would be a financial burden at this point.
