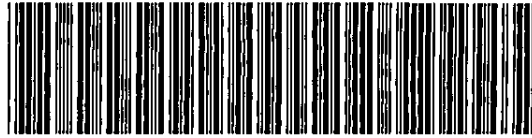

The name of the Company that shall be dissolved is CLASSIC PROCESS EQUIPMENT, INC. (the "Corporation").

The Articles of Dissolution will be effective upon filing with the Florida Department of State.

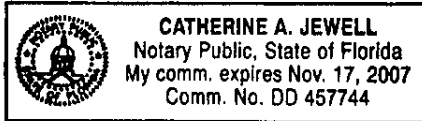
