Article VI is hereby deleted in its entirety and replaced with the following:

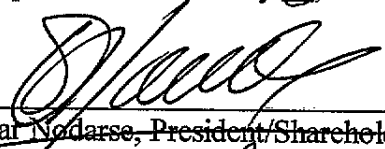
