This corporation shall indemnify any officer or director, or any former officer or directors, to the full extent permitted by law.

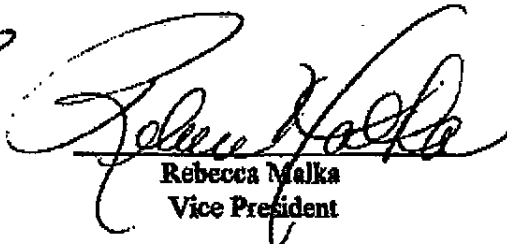

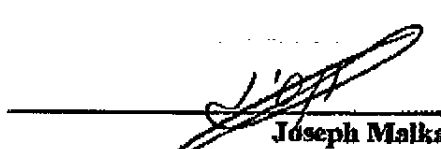
