ARTICLES OF INCORPORATION OF

THE LINKS AT THE STRAND DEVELOPMENT CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is The Links at the Strand Development Corporation. The principal office, if known, or the mailing address of the Corporation is 6355 - 22nd Avenue Northwest, Naples, Florida 34119.

Article 2.
Duration

The duration of the Corporation is perpetual.

Article 3. Purpose
