**ARTICLES OF INCORPORATION
OF
SCARLETT C. BUSTILLO, D.D.S., P.A.**

**ARTICLE I
NAME**

The name of this Corporation is Scarlett C. Bustillo, D.D.S., P.A.

**ARTICLE II
DURATION**

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.

**ARTICLE III
PURPOSE**

The general purposes for which the Corporation is organized are the following:


The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.
