# ARTICLES OF INCORPORATION OF S&W PROPERTIES OF NAPLES, INC.

The undersigned subscriber to these Articles of Incorporation, L. I. Smith, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### CORPORATE NAME

The name of this Corporation is S&W PROPERTIES OF NAPLES, INC. The principal office and mailing address of the corporation is 5170 10th Avenue S.W., Naples, Florida 34116.

#### ARTICLE II

#### <u>DURATION</u>

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

#### ARTICLE III

#### **PURPOSE**

#### CAPITAL STOCK
