### ARTICLES OF INCORPORATION OF NCT ACQUISITION CORP.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing with the Florida Secretary of State the following Articles of Incorporation for the purpose of organizing a business corporation for profit under the laws of the State of Florida.

#### ARTICLE I

#### NAME OF CORPORATION

The name of the corporation ("Corporation") is NCT Acquisition Corp.

#### ARTICLE II

#### ADDRESS OF CORPORATION

#### ARTICLE III

#### **DURATION AND PURPOSE**

#### ARTICLE V

#### INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the Corporation's registered office is 222 W. Comstock Avenue, Suite 210, Winter Park, Florida 32789, and the initial registered agent at such address is Robert P. Saltsman. The board of directors from time to time may move the registered office of the Corporation to any other address in the State of Florida.

#### ARTICLE VI

#### **BOARD OF DIRECTORS**

There shall be a board of directors for this Corporation that shall consist of not less than one (1). Except for the number constituting the initial board of directors, the number of directors shall be decided by the resolution of the shareholders. #### ARTICLE X

#### ARTICLE XI

#### AMENDMENT TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended any time by a resolution adopted by a majority vote of the board of directors at any annual or special meeting, provided at least ten (10) days' written notice is given to each director at the time and place of the meeting and the purpose thereof. Any amendment of these Articles of Incorporation so made must be approved by a majority vote of the shareholders of the Corporation.
