We are writing this letter to respectfully request special consideration in the abatement of the penalties assessed for non-filing of the 2001 and 2002 Uniform Business Reports and provide the following explanation in relation thereto. We also enclose full payment for the annual fees for years 2001 & 2002.

Our accountant has recently notified us that the Company is "INACTIVE" per the Public Inquiry of the Florida Department of State, Division of Corporations on the internet. We have been in contact with the Department and have been told that the Company has been Administratively Dissolved due to Non Filing of the Uniform Annual Reports (UBR) for the years 2001 and 2002.

We emphatically confirm that we did not receive the 2001 UBR and are prepared to testify as such under oath. Please be assured that we would have immediately filed the Report if we would have received it in January 2001 in view that on December 8, 2000 we reinstated the Company.

In view of the reinstatement in December 2000, we did not take any action upon not receiving the 2001 Uniform Business Report in January 2001. We also attest to the fact we did not receive any notifications of non-filing the 2001 UBR. As explained below, we have been subjected to a serious medical problem leading to the lack of filing the 2002 UBR (that we were not sent due to the Administrative Dissolution).

As a result of the medical attention and hospitalization required related to a cerebral stroke I was afflicted by earlier this year, my family and myself have undergone significant mental stress and hardship. This has contributed to the lack of attention to various aspects of my business including the oversight in the filing of the 2002 UBR.
