The name of the corporation is: **Paul Selwyn, Inc.**

This corporation shall be perpetual and become effective as of the filing of these Articles with the Secretary of State, Division of Corporations.

**ARTICLE III - PURPOSE**



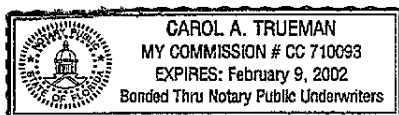


