

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### **ARTICLE 1**

The name and initial address of this Corporation shall be: Digestive Disease Endoscopy Center, Inc., 7421 N. University Drive, Suite 307, Tamarac, FL 33321.

#### **ARTICLE II**

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### **ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

The consideration for all of the said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Corporation.

#### **ARTICLE IV**

This Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

#### ARTICLE V

The initial registered office of this Corporation shall be 7421 N. University Drive, Suite 307, Tamarac, FL 33321 with the privilege of having its offices and branch offices at other places within or without the State of Florida. The initial registered agent at that address shall be Nicholas C. Katz, M.D.

#### **ARTICLE VI**
